#### Description

Intergrain UltraClear Exterior is a tough, clear, marine grade water based timber finish for use on window frames, doors and trims. Incorporating UV absorbers, UltraClear Exterior provides superior protection against the weather including the harmful effects of the sun's UV radiation. Available in gloss and satin, UltraClear Exterior has a low odour and unlike oil based coatings will not yellow. Easy to apply and fast drying, UltraClear Exterior allows for several coats to be applied in one day. UltraClear Exterior may be applied over Intergrain NaturalStain™ to give a gloss or satin finish. Note: UltraClear Exterior is not suitable for coating areas subject to foot traffic. The UV absorber system in UltraClear Exterior will impart a subtle transparent brown tint.

#### #ENVIRONMENTALLY RESPONSIBLE:

Being water based, UltraClear Exterior emits significantly less VOC's (volatile organic compounds) into the atmosphere than traditional oil based exterior clear finishes. This makes UltraClear Exterior safer to use, and much gentler on the environment.

#### Uses

On exterior timber doors, window frames, trims and eaves. UltraClear Exterior can also be used on the inside of exterior doors and window frames.

Note: UltraClear Exterior is not suitable for areas subject to foot traffic (such as decks and walkways) or broadwall. For these areas use Intergrain UltraDeck® or Intergrain NaturalStain.

#### **Precautions And Limitations**

Do not apply to hot surfaces or those in direct sunlight, as doing so may result in difficult application.

Do not apply in temperatures above 35°C, below 10°C or if rain or dew is expected within four hours of application. Lightly dampening timber before painting will ease application in temperatures above 28°C.

| Surface<br>Preparation                       | <ul> <li>NEW BARE TIMBER.</li> <li>Sand timber to a uniform, smooth surface. Ensure the timber is dry and free from all dirt, dust, wax and oils. Clean oily timbers, such as<br/>Brushbox, Spotted Gum, Cypress or Tallowwood with methylated spirits and allow to dry. Note: Do not use steel wool on timber to be<br/>coated with UltraClear Exterior as severe staining will occur.</li> </ul>   |
|  | PREVIOUSLY PAINTED, STAINED, OILED OR VARNISHED TIMBER.<br>All paints and coatings that seal the surface must be thoroughly removed back to bare timber. To remove coating sand, or use a<br>combination of Intergrain Liquid 8 <sup>™</sup> Timber Stripper* and sanding.   |
|  | WEATHERED, GREY OR MOULDY TIMBER.<br>Sand timber back to a fresh surface, and remove sanding dust. Note: The rounding of sharp edges with sandpaper is highly recommended<br>to maintain coating film thickness.   |
|  | ALL COMPOSITES & BAMBOO SUBSTRATES.<br>Sand, remove sanding dust, then check for adhesion by applying UltraClear Exterior to a test area, approximately 250mm x 250mm. | Application<br>Procedure<br>And<br>Equipment | <ul> <li>Do not apply with a roller.</li> <li>Stir thoroughly before and during use with a flat blade stirrer.<br/>To ease application and achieve the best possible finish when coating large areas or in warm conditions, add Intergrain Hot Weather<br/>Additive<sup>™*</sup> to UltraClear Exterior as per the label instructions.<br/>Apply three coats of UltraClear Exterior with a quality synthetic or pure bristle brush, pad applicator or spray (air assisted airless or<br/>airless). FOUR or more coats will be required in extreme conditions such as full sun exposure, marine environments and in humid areas,<br/>and may be required on porous timbers.
